 - a. Waushara County EMS Emergency Medical Services Mutual Aid Agreement Krueger reported that Lifestar signed the Mutual Aid Agreement in April for Waushara County EMS. The agreement covers all three municipalities of the EMS District. Additionally, all other mutual aid is going well. The EMS District's partnership with Wisconsin Rapids is good.
- 6. Discussion only Update regarding the Mutual Aid Box Alarm System (MABAS) for Adams County Carlson reported implementation of MABAS is going very well. MABAS has been used a series of times already and there has been a good team effort between departments and dispatchers. Happy to report it is in place and working.

Discussion and possible action Review Financing Formula Calculation for 2024 service cost for the Ambulance and Emergency Medical Services Agreement with term ending December 31, 2024 A draft calculation was provided to all municipalities with the meeting packet. It was asked of each municipality if they were comfortable with the break down and all agreed the calculation was

correct. Administrator Gebert asked if the calculation wasn't already, that it be provided to Clerk/Treasurer or Treasurer for budgeting purposes. All municipalities will forward the numbers provided to their respective 2024 budgets.
