**The Town of Big Flats will NOT be collecting dog license payments. **

The Town of Big Flats Treasurer will accept first installments and full payments of <u>PROPERTY TAXES</u> through January 31, 2026, by one of the following three methods:

PLEASE NOTE:

If you want your payment posted in 2025, it must be IN OUR OFFICE BY 1:00pm - December 31, 2025

- Make checks payable to: Town of Big Flats.
- PLEASE PUT YOUR PHONE NUMBER ON YOUR CHECK.
- Tear <u>ONE</u> of the three <u>STUBS</u> off the bottom of your tax bill, for the amount you are paying, and send along with your payment.
- Multiple property payments may be made with one check.
- Check returned Non-Sufficient Funds (NSF) will be charged a \$30 fee.
- Overpayments of less than \$5.00 will not be refunded unless requested in writing by the landowner.

PAYMENTS BY MAIL --

- If you want a receipt, enclose a <u>self-addressed STAMPED envelope</u> with your payment. *** NO STAMPED ENVELOPE, NO RETURN RECEIPT***
- If an Escrow/Mortgage Company is making your payment, Please make sure they have the correct mailing address AND include your tax parcel number with the payment. Payments are being delayed and/or returned as they are being sent to the wrong address and/or no information as to what parcel to apply the payment to.

PAYMENTS made After January 31, 2026, must be sent/delivered to:

As per Statute 74.69, payments could be deemed not timely if improperly/incorrectly sent to the wrong office!

ATTENTION PET OWNERS:

**The Town of Big Flats will NOT be collecting dog license payments. **

All dogs 5 months of age or older must be licensed annually under Wisconsin Statutes Chapter 174. Licenses are due by January 31, 2026. A late fee may apply after this date.

All licenses must be obtained from the Adams County Treasurer, 401 Adams St, Suite 11, Friendship, WI 53934 To obtain your 2026 dog license include the below required items:

- A check payable to Adams County Treasurer:
 - o \$8.00 for spayed or neutered / \$13.00 for full male or female
- A copy of the current rabies vaccination certificate
- A self-addressed, stamped envelope for your license return, if mailed in.

Visit the **Adams County Treasurer's Office** during regular business hours to process your dog license in person or send the required items in the mail.

Can't Read Your Fire Sign? Having a Legible Fire Sign is the Property Owners responsibility. A Replacement Fire Sign is \$40.00. This makes it easier for Emergency Services to find you!! An application can be found at https://www.bigflatswi.com/replacement-fire-sign/. Please fill out the application and drop off or mail to the Town of Big Flats Clerk, 1104 County Road C, Arkdale, WI 54613. \$40.00 payment must be included with the application to process it.

Do you have your annual, free DNR burning permit?

The number one cause of wildfires in Wisconsin is debris burning. A free annual burning permit is required by the DNR to burn when the ground is not completely snow-covered. Once a person has obtained a burning permit (by phone or online), it is their responsibility to check the burning restrictions daily after 9:00 a.m. on any day they wish to burn. Burning restrictions can be checked over the internet at dnr.wi.gov, keyword "burn permit" or by phone at 1-888-WIS-BURN (947-2876). Cooking and warming fires do not require a burning permit, but people should be aware of the weather conditions so that they choose to burn at the safest time. Stay with your fire and make sure it is completely extinguished before you leave it.
